

**LENGTH OF STAY GUIDELINES**

**TIER ASSIGNMENTS FOR RETIRED VIRGINIA CRIME CODES**

**(PURSUANT TO 2023 AND 2024 LEGISLATIVE CHANGES)**

Section 6.22 of the 2023 Length of Stay Guidelines provides, “if a juvenile was committed for: (i) violating the terms or conditions of probation, (ii) violating a court order, or (iii) violating a suspended commitment, then the most serious underlying offense will be used to determine the most serious committing offense severity tier.”

The guidelines include several appendices assigning one of five offense severity tiers to each active Virginia Crime Code (VCC). Because VCCs may be retired when legislative changes eliminate the need for the VCC or necessitate a new VCC, the underlying offense on the probation, court order, or suspended commitment violation may involve a retired VCC for which no tier has been assigned under the 2023 Guidelines. Pursuant to Section 6.22 of the Guidelines, which gives the department director the discretion to add new offenses, eliminate repealed offenses, or move offenses to alternative tiers in accordance with applicable legislative changes made by the Virginia General Assembly, the tiers assigned to the retired VCCs are as follows:
